In the event that TestMasters determines that any of the aforementioned covenants have been breached by me, in addition to all other legal remedies TestMasters has against me, I agree that TestMasters can stop providing tutoring services to me without a refund. I also agree that TestMasters has the right to stop providing me with tutoring services at any time for any reason with a prorated refund.

TestMasters makes no guarantee, express or implied, regarding the score improvement of any student who receives private tutoring.

REFUND POLICY

I understand that once TestMasters has secured private tutoring and I have signed this agreement, I am not entitled to any refund of the tuition, regardless of whether or not I have received the private tutoring.

CANCELLATION/RESCHEDULING POLICY

I understand that any changes to scheduled tutoring appointments must be made at least 48 hours prior to the time of the original appointment. I further understand that if I fail to meet at the scheduled time, or arrive late, I will forfeit the tutoring fees for any time that I miss.

TUTOR AVAILABILITY

I understand that I can receive private tutoring only if a TestMasters tutor is available. If a tutor is not available for a portion of the requested tutoring time, a pro-rated refund will be issued by TestMasters to compensate me for any outstanding hours.

RETURNED CHECK POLICY

I agree to promptly pay a \$50.00 service fee for any check written by me that is not honored by my bank for any reason.

PERSONAL JURISDICTION

I agree that this agreement shall be governed by California law, and any litigation arising out of this agreement shall be commenced in Los Angeles County, California. To adjudicate any such litigation, I consent to the jurisdiction of the California courts even if my residence is in another state or country and I would not otherwise be subject to such jurisdiction.
